CONDITIONS AND REGULATIONS OF DIVERSION**

1. Obey all City, County, State, and Federal laws.
  2. Pay to the Clerk of the Sandusky Municipal Court:

  3. Report to and carry out the regulations of the Probation Officer, who may modify or clarify these regulations, which include:
    - a. Report not later than the 10<sup>th</sup> of each month between the hours of 8:00 a.m. and 4:00 p.m. or as otherwise directed by the Probation Officer.
    - b. Not leave county of residence, or the State of Ohio, or change my residence without prior approval of the Probation Officer.
    - c. Not associate with undesirable persons (convicted persons or others that might lead me to violate the law), without prior approval of the Probation Officer, including these persons:
    - d. Maintain full-time verifiable employment or school status, or a combination, and immediately inform the Probation Officer of any change in such status.
    - e. Shall not consume any alcohol or be found in any establishment where alcohol is sold and consumed.
    - f. Avoid contact with and/or use of marijuana, dangerous drugs, or narcotics, except those prescribed by a physician or dentist; and submit to urinalysis, chemical testing, and/or Breathalyzers as required by the Probation Officer.
    - g. Immediately inform the Probation Officer when I have **ANY** contact with law enforcement.
  - h. Submit my person and property to search and seizure at any time when so requested by a Probation Officer, with or without probable cause. Subject to random home visits while on diversion, with or without probable cause.
  - i. Neither carry nor own any weapons without consent of the Probation Officer, otherwise they will be confiscated.
  - j. Not visit any gambling places, illegal after-hour establishments or places where the law is violated by others.
  - k. Shall not own or operate a motor vehicle without having displayed a valid license and evidence of liability and property damage insurance.
4. You must successfully complete Alcohol Edu, an online, educational underage drinking program no later than \_\_\_\_\_. Cost is \$75 and must be paid before you can take the course.
  5. You must successfully complete seven (7) hours community service \_\_\_\_\_. Community service must be completed by \_\_\_\_\_.

**The Court may, at any time, revoke, or modify any condition of the diversion program, and reduce or extend the period of diversion as provided by law.**

**It is understood and agreed that any violation of these terms will result in the Court's acceptance of the no contest plea and enter a finding of guilty and proceed with sentencing.**

**It is further understood that upon successful completion of the above specified period of diversion, the case will be dismissed.**
